\* The annual card account maintenance fee is debited even if the client has not made transactions on the card account..

\*\* Extra insurance deposit would be not required for the additional card issued to the main card. The amount of the insurance deposit of the main card will be extended to all cards assigned to the client's account.

\*\*\* Issuance of an additional Visa Classic (USD) card for a person aged 6 to 16 years, linked to a primary card issued to an adult client is free of charge. To Apply it is necessary to provide the child's birth certificate.
