\*\* For bank transfers in foreign currency, carried out by individuals through a mobile application, the SWIFT commission is not charged.

\*\*\* In the event of a payment refund for cross-border payment services using the “ALIPAY+” QR code, the bank’s commission is non-refundable to the user.
