If the 15th day of the month falls on Friday or a pre-holiday day, interest for weekends or holidays is accrued and capitalized on the card account balance on the same day.

\*\* In the following cases - free of charge:

1. Payments for all types of state duties and administrative fines
2. Payments for government services provided by government service centers, including through the Unified Portal of Interactive Government Services
3. Payments in favor of educational institutions, as well as healthcare institutions registered in the MUNIS system

4. Payments for all types of utilities
  5. Payments for the compulsory execution of judicial acts and acts of other bodies, collected by the bodies of the Bureau of Compulsory Enforcement
  6. Payments to the Electronic trading platform "E-auksion" and the automated information system "K-Savdo"
  7. Payments for the purchase of tickets for travel on air, rail and other types of public transport
  8. Payment of taxes (including penalties and fines on taxes)
  9. Payments to the accounts of JSC "UZAUTO MOTORS"
  10. Accepted as a down payment on loans issued by JSCB "Asia Alliance Bank", as well as for payment of insurance premiums on them
  11. Accepted for international money and bank transfers
  12. When returning funds that were mistakenly credited to a client's account, based on a client's application
  13. To accounts opened in the JSCB "Asia Alliance Bank" system in other cases, except for transfers through the Munis system
- \*\*\* Issuance of additional Uzcard and Humo cards for a person aged 6 to 16 years, linked to a primary card issued to an adult client is free of charge. To apply, it is necessary to provide the child's birth certificate.

**\*\*\*\* Issuance of primary and additional card at all bank branches, as well as their issuance and delivery via the Alliance Pay mobile app, is free of charge from June 1, 2026 through August 1, 2026 (including).**
